In exchange for Fox Television Stations, Inc., on behalf of its station WHBQ (“Station”) allowing my child or legal ward to attend the Weather Camp event (the “Event”) on August 6, 2011, I make the following representations, warranties, agreements, and releases:

1. I confirm my child/legal ward will be in grade 3rd through 6th for the 2011/2012 school year.
2. I agree that my child must be accompanied by a Parent/Legal Guardian or designated chaperone over the age of 18 at all times during the Event (up to 5 children per adult).
3. This registration form must be filled out and returned by August 2, 2011. (You can submit your registration online or print out and deliver to Station at Weather Camp, 485 S. Highland, Memphis, TN 38111). Registration is limited and spots will be designated on a first come-first served basis.
4. I understand that the Event will be filmed and I agree that Station shall have the right to film me and/or my child/legal ward in connection with our attendance at the Event. I agree that Station, its successors, licensees and assigns, are and shall be the sole and exclusive owner of the results and proceeds of such filming activities (the “Materials”), including, without limitation, all rights (including copyrights) and components contained therein, for all purposes and uses whatsoever, throughout the universe and forever. Without limiting the preceding sentence, Station and its successors, licensees and assigns shall have the sole and exclusive right to distribute, license, exhibit, advertise, publicize, promote and otherwise exploit the Materials or any part thereof and any and all rights therein, in all media, and by any manner, means or technologies, all without any restrictions or conditions of any kind. Station shall also have the unrestricted right to edit the content of the Materials in any manner or form.
5. I, on behalf of myself and my child/legal ward, and our respective heirs, assigns, guardians and legal representatives, hereby agree to release and hold Station, its parent, subsidiary and affiliated entities, and each of their officers, directors, employees, licensees, agents and assigns harmless, and indemnify

each of them, from and against any claim, damage, demand, debt, liability, account, reckoning, obligation, lien, action, cause of action, cost and/or expense (including, without limitation, attorneys' fees and disbursements), whether or not litigation has commenced, arising from or in any way related to my or my child/legal ward's participation in the Event and/or my or my child/legal ward's presence on or about the premises where the Event is conducted and/or recorded. This paragraph covers all claims, except to the extent that a claim is the result of the willful misconduct of Station.
